# 1 What OASIS is



**Overall Assistance for Startup Immigration System(OASIS)** is a program operated by Global Startup Immigration Center designated by the Minister of Justice and the Minister of Small and Medium Venture Businesses.





## 2 What OASIS provides

**OASIS**(Overall Assistance for Startup Immigration System) provides **both start-up support and start-up visa (D-8-4) to foreigners** who decide to launch business in Korea based on outstanding ideas and technology.

<b>OASIS-4*</b>	<b>Basic Start-up Class (25 Points)</b>
OASIS-5	Start-Up Coaching & Mentoring (15 Points)
OASIS-6	Invention, Start-Up Exhibition (25 Points)
OASIS-7	Graduation from Start-Up Incubation (15 Points)
OASIS-8	Support for corporation establishment (15 Points)
OASIS-9	Support Start-Up Items Commercialization (25 Points)

## 4 What we provide

### OASIS-1: Basic Intellectual Property Course

required to acquire (apply for) **intellectual property rights and to stay in Korea.**

Total of 12+@ hours (4-8 hours a day, 2 days),  
all courses are provided in a proper language  
for participants and a minimum attendance of  
80% is required for the completion.



## 4 What we provide

### OASIS-4: Basic Start-up Class

equipped with **basic technologies for a business start-up**

A total 20 hours (3 days), all courses are provided in a proper language for participants and a minimum of 80% attendance is required for the course completion



## 5 Benefits of the OASIS

- A. **Only** start-up program **for foreigners** in Korea
- B. **Possible to change to D-10 visa**
- C. **Begin start-up** with small capital
- D. **No validation date** of OASIS **point**

### Requirements for Start-up Visa

- Bachelor's degree/ Associate's degree(from Korea)
- 80 or more points(at least one required item should be included)
- Corporation establishment
